

Housing market developments - 3rd quarter 2022

Strong house price growth in the province of Drenthe and Overijssel

Average house prices increased the most in the provinces of Flevoland and Overijssel with 14.1% year on year. The municipality of Steenwijkerland is currently registering the fastest growth rate of all the municipalities in the Netherlands with 16.4%. The largest cities, Amsterdam and Rotterdam, show average house price increases of respectively 6.4% and 9.8%. Utrecht and The Hague show an average house price increase of resp. 5.4% and 8.8%.

Transactions decreased and number of homes for sale decreased

The annual number of sales decreased to 238.000 houses. The number of homes for sale decreased. The ratio between the number of sales and supply has reached a factor 0.3 (sales > supply).

Housing affordability declined

On average, 20.1% of net household income was required to service housing costs, in 2008 the housing affordability peaked with 27.0%. The relatively good affordability in the last years was mainly the result of the low mortgage interest.



Average house price keeps rising

- The WOX (1995 = 100) currently stands at 473 points.
- Average house price: € 463.000.
 - » Q-O-Q price development: +0.7%.
 - » Y-O-Y price development: +11.2%.
- The current Dutch inflation rate is 14.6% (which is the average rate for Q3 2022 according to Statistics Netherlands). In the third quarter of 2022, inflation-adjusted house prices decreased by 3.4% y-o-y.



- Average price of a single-family house: € 489.000.
 - » Q-O-Q price development of single-family houses: +1.2%.
 - » Y-O-Y price development of single-family houses: +12.0%.
- Average price for apartments: € 395.000.
 - » Q-O-Q price development of apartments: -0.8%.
 - » Y-O-Y price development of apartments: +8.4%.

Highest price increase price class less than € 150,000

- Based on house price levels, Calcasa has divided the market into five price classes. Homes in the price class less than € 150,000 performed best with an annual average house price rise of 12.3%.
- The price class € 350,000 to € 500,000 increased the least in value; over the past year these homes increased in value by 10.6%.

(Semi-) detached houses show biggest price increase

- (Semi-) detached houses built after 2000 are registering the fastest growth. Their value increased by 15.0% in the past year.
- built before 1944 Apartments are registering the growth. Their value increased by 7.0% in the past year.

Y-O-Y price change apartments: 2.7%.

Strong house price growth in Drenthe and Overijssel

- Average house prices increased the most in the province of Drenthe and Overijssel, with an annual increase of 14.1% in value.
- Single-family houses are in are in demand in Drenthe, with values going up by 14.6%. Apartments prices increased with 8.9%.
- The lowest price increase was measured for houses in the provinces of North Holland (9.0%), South Holland (10.3%) and Utrecht (10.3%).

North Overijssel fastest growing region

- The largest annual price increase of 15.7% is measured for houses in the NUTS III region of North Overijssel. The average house price in this region is € 393,000.
- Second-largest annual price increase is seen in the NUTS III region Arnhem/ Nijmegen with an annual growth rate of 14.9%, here the value of singlefamily homes rose by 15.2% and the value of apartments by 13.9%.
- The NUTS III regions with the smallest price increases are Groot-Amsterdam (8.5%) and Haarlem (6.0%).
- In 7 of the 40 NUTS III regions the annual increase for houses prices is less than 10%.



Housing affordability

On average, 20.1% of net household income was required to service housing costs in the third quarter of 2022, compared to mid-2008 when housing costs represented 27.0% of net income.

- Q-O-Q change in net housing costs: 18.1%.
- Y-O-Y change in net housing costs: 42.9%.





Affordability index per municipality (in %). Source: WOX Monitor Calcasa


*The index measures the affordability of Dutch owner-occupied houses. It is calculated taking into account net housing costs, current average mortgage costs (current interest rate, maintenance costs, local taxes and fiscal treatment.



Number of sales

The annual number of transactions has decreased. 238.000 residential properties were sold during the past year.

- Y-O-Y development, number of annual sales: -20.0%.
- Q-O-Q development, number of annual sales: -2.0%.



Number of sales by housing type

- Transactions of detached houses decreased the most with 24.1% in the third quarter of 2022.
- Apartment sales decreased this quarter with 18.4% year-on-year.



Sales in expensive price class increased

- The sale of homes in the price range € 350,000 to € 500,000 increased by 20.9% in the past year, whilst homes above € 500.000 increased by 39.0%.
- Especially in the east (50.8%) and in the north (61.5%) of the Netherlands more expensive homes (> € 500,000) were sold.
- In the south the highest increase in sales was measured for houses in the price range above € 500,000 (39.3%).
- The lowest price segment (€ 75,000 to € 150,000) decreased in the western part of the Netherlands by 40.2%.



29% of housing sales within € 350,000 to € 500,000

- In the past year 15% of housing sales were within the price class of € 150,000 to € 250,000.
- The percentage of transactions in the price class € 75,000 to 150,000 decreased in four years time from 14% to 3%.
- The price segment € 350,000 to € 500,000 increased in four years time from 14% to 29%.
- 27% of housing sales were within the price class of € 500,000 or more. Four years ago this was 9%.

Share of housing sales per price class



Groot-Amsterdam highest market liquidity

- In the NUTS III region Groot-Amsterdam 6.4% of the housing supply was sold during the past year. The regions The Hague and Groot-Rijnmond follow with 6.0% and 5.9% respectively.
- The NUTS III region IJmond has the lowest market liquidity: 4.3%.



Market liquidity: number of sales surpassed supply

- The annual ratio of houses for sale vs. sold has increased to 0.3. A year ago this ratio was 0.2.
- The annual number of houses sold: 238,000.
 - » Y-O-Y development: -20.0%
- Homes for sale in Q3 2022: 65,000
 - » Q-O-Q development: -6.7%
- The market liquidity is best in the municipality of Urk with a factor of 0.12.
- In the municipality of Wassenaar the market liquidity is highest (worst) with a factor of 0.47.





- The relationship between the supply of owner-occupied housing and total owner-occupied housing stock is also a component of market liquidity. The percentage of the total owner-occupied housing stock that sold last year is 5.3% for the Netherlands.
 - o The percentage of family homes sold previous year: 5.5%.
 - The percentage of apartments sold previous year: 4.9%.
- The share of owner occupied housing stock which was sold last year is highest in the city of Amsterdam with 8.4%.
- In the municipality of Dinkelland only 2.9% of the existing stock of owneroccupied homes has changed owners.

Annual number of properties for sale versus number of properties sold in the Randstad. Source: Multiple real estate agents, adaptation Calcasa





Percentage of properties with energy label A per municipality



Mortgage approvals

Approximately 502,000 mortgages were approved last year.

- Y-O-Y development, number of annual mortgages: -1.5%.
- Q-O-Q development, number of annual mortgages: -2.9%.



Number of foreclosures

Over the last four quarters, 226 foreclosures have been registered by the land registry.

- o Y-O-Y development amount of annual foreclosures: -35.4%.
- o Q-O-Q development amount of annual foreclosures: -4.6%.
- The share of foreclosure sales versus total sales is 0.1%.
- The highest share of foreclosure sales to total sales is 1.6% in the municipality of Nederweert.
- 227 municipalities had no foreclosure sales in the past year. The largest municipality without foreclosure sales is Amersfoort.

Note that many foreclosed properties will be sold via the public market and not via auction. The reason is that proceeds of a sale of a home through a forced auction can be less compared to a sale via the public market.




Number of yearly foreclosures and amount of foreclosures as a % of the total number of transactions in the Netherlands.

Average price newly built homes increased

- In the second quarter of 2022 the total amount of sales for newly built homes was 7.600. This is a decrease of 13.9% year-on-year.
- During the second quarter of 2022 the average price for newly built houses was € 518.000. This is an increase of 16.4% compared to a year ago.



Amount of households in arrears decreased

- Since 2015 the number of homeowners with payment problems decreased with 69%.
- At the beginning of 2022 there were 35.000 homeowners who had difficulty paying their mortgage: this is a decrease of 6.8% compared to a year earlier.








Year-on-year price change per municipality (%).

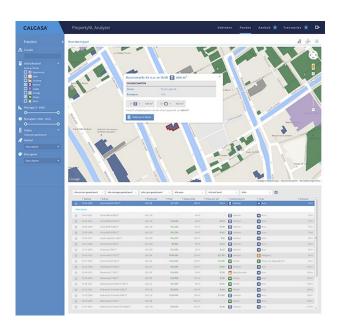

Calcasa WOX: A reliable house price index

Calcasa WOX is demonstrably the most reliable house price index in the Netherlands. Every quarter, Calcasa calculates a reliable house price index for each province, municipality, borough and neighborhood in the Netherlands. The house price index is calculated using the national data on transactions starting from 1993 and additional house and location characteristics from the database. The source data is screened for integrity, such that non-representative data is omitted for the index calculation. The developed methodology takes into account any over or under representation of sold properties, compared to the existing housing stock in that area. Unlike most house price indices, the Calcasa WOX does not simply calculate the coincidental development of sales for a specific area; rather it calculates the development of prices of the total housing stock.

European AVM Alliance (EAA)

Calcasa is a founding member of the EEA which was launched as a pan-European initiative at the end of 2012. The mission is to promote and standardize the usage of AVM's resulting in a consistent approach to automated valuations in Europe. Other members include Hometrack (UK), Eiendomsverdi (Norway), Värderingsdata (Sweden), CRIF (Italy), Tinsa (Spain), On-Geo (Germany) and On-Geo (Austria).
